What is RAC Warranty?

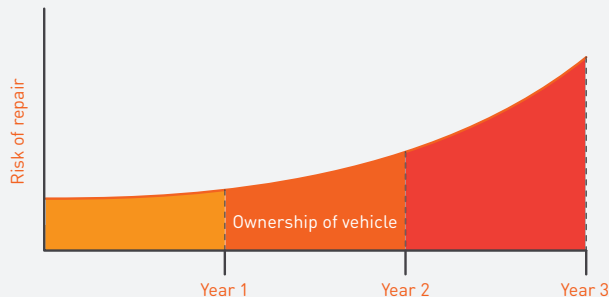
When buying a used car, van or motorbike you can often be left without the same reassurance that comes with buying a new vehicle with a manufacturer's warranty.
